Food assistance for those under age 60. Kinship care provides support services to caregivers of children under age 18, other than the parent, who is related by blood, marriage, or adoption. The child must be living with

the caregiver. Family income must be less than or equal to 200% of the federal poverty level. Support services are designed to deal with a specific crisis. Not intended to meet recurrent on ongoing needs. Will not extend beyond 4 (four) months. Specified dollar limits are set per child, per year, per service. All referrals may be made only from the Public Assistance & Child Welfare staff at the local Department of Human Resources. Caregivers must apply in the county where they and the child reside.

Alabama Medicaid Waiver – <u>www.medicaid.alabama.gov</u> Nursing facility level of care with no age requirement. Provides case management, home maker, personal care, ADH, respite (skilled & unskilled), companion and home delivered meals. Anyone who is denied Medicaid eligibility for any reason has a right to appeal. Contact SARCOA (334)793-6843 to be screened and for more information.

Medicare Hospice & Home Health Benefits –Hospice is a program of care and support for people who are terminally ill and their families. Services typically include physical care, counseling, drugs, equipment, & supplies for the terminal illness and related conditions. Care is generally provided in the home. Family caregivers can get support.

Hospice agencies also offer Palliative Care options. Palliative care can address your physical, intellectual, emotional, social, and spiritual needs, and supports your independence and access to information.

To find a hospice/palliative care provider, talk to your doctor, or call your state hospice organization.

Home health care is usually less expensive, more convenient, and can be just as effective as care you get in a hospital or skilled nursing facility. In general, the goal of home health care is to provide treatment for an illness or injury. Where possible, home health care helps you get better, regain your independence, and become as self-sufficient as possible. Medicare pays for you to get healthcare services in your home if you meet certain eligibility criteria and if the services are considered reasonable and necessary for the treatment of your illness or injury.
